- Shall be responsible for verification that soft count and ETICKETs amounts from the Thunder Bird and Casino actually transferred into the SDS system after the Count Team has finished.
- Create the accounting reports.
- Create reports and balance from Back Office for Kiosk machine.
- Create liability reports.
- Create cashier reports and balance to the SDS system.
- Perform analytical requirements in regard to the slot machines and forward to the Accounting Supervisor.
- Assist with regulatory requirements and Policies and Procedures.
- Assist in the maintenance and trouble shooting of the Finance accounting software.
- Any other duties as assigned by the Accounting Supervisor.
